PRODUCTS LIABILITY AND TOXIC TORTS

Houston-based Tracey Law Firm handles cases in products liability for plaintiffs across the country. Focused particularly on pharmaceutical liability and toxic torts, the firm's attorneys represent plaintiffs in Texas, California, Pennsylvania, Ohio, Oklahoma, New York and Kentucky in benzene cancer cases, Yamaha Rhino rollover cases and drug litigation. "We handle any kind of serious personal injury case, but we focus on products liability," says Sean Patrick Tracey.

In addition to more than 100 pharmaceutical cases and 60 to 70 other products liability cases, Tracey also takes on a handful of select medical malpractice cases. "What we're not are mass tort lawyers—I don't have thousands of clients," says Tracey. "We try to focus on keeping the clients at a manageable number, so that we can handle real cases with real people. This is not a 'Wal-Mart' practice. Our clients are 'clients' and not inventory."

PERSONALIZED SERVICE

Because the firm does not take on thousands of cases, clients receive individualized attention. "It's a very personal experience given the level of litigation we're doing," says Tracey. "We work really hard on each case, and our clients are extremely happy with the results we've gotten for them."

RHINO ROLLOVERS

Tracey has been involved in the Rhino litigation since the beginning. His firm serves as one of six on the Plaintiffs' Executive Committee of the Rhino MDL (the group prosecuting Rhino cases nationwide). "We have a lot of clients that have been very badly injured," says Tracey, who also cites the death of a 21-year-old mother.

PAXIL BIRTH DEFECTS

Currently, the firm is also working on approximately 70 suits related to birth defects caused by Paxil. "I filed the first Paxil birth-defect case in the country," says Tracey, who settled the suit last December. His philosophy, however, is always to prepare cases as if already set for trial. "We're not a warehouse for lawsuits," he says. "The way you get
